123.8.a. Car Park – Parish Council have submitted a planning application for the proposed Car Park in Satterthwaite.

The Rusland Valley Community Trust are looking into giving the Parish Council some money for the play area in the village, and the upkeep of the tennis court. With this we will look to leaving some tennis rackets out near the court on the shed veranda so anyone can use the facility.

We will be consulting residents in Satterthwaite about the proposal of yellow lines around the junction beside the Church and part way along the road opposite the Parish room.

If anyone is interested in interested in B4RN which will provide high speed internet to the village you will need to go on to their website and register your interest.

Coniston are looking to get Bathing Water status Award for the lake this year. The Parish Council is to send a letter of support.

We are urging people to check for Hedgehogs when doing any new building works as they are know to nest in areas where they will be warm and protected. This is inline with Protecting Hedgehogs in Cumbria.

Still no news as yet on the 20pmh limit for the village.

Rural Crime Initiative – the cameras are up and running again after a period of maintenance. Spreadsheets are being filled in as per our agreement for when the camera data is accessed when crimes have occurred, and this is held under data protection.
